If a rep or judge cancels a show less than 30 days out and you have a signed agreement with said judge/rep, that judge or rep is responsible to refund the host if airplane tickets were purchased. Also, if said host cancels a show less than 30 days out and the judge/rep has a signed agreement, the host will be fined \$50.00 by the ABKC, which will then be reimbursed to the judge/rep for their inconvenience. (These fees can be waived if there was a true unavoidable emergency, but you must provide proof)
